## **St Martin's CE Primary Academy - Remote Learning Provision**

At St Martin's CE Primary Academy, we are committed to ensuring that all our pupils receive a high-quality education, even when they are unable to attend school in person. While we prioritise in-school learning, remote education will be provided as a last resort in situations where attendance is not possible but children are still able to learn.

### **When Remote Learning Will Be Provided**

Remote learning will be considered in the following circumstances:

- **School Closures or Restrictions on Attendance:** If government or local authority guidance necessitates the partial or full closure of the school, remote learning will be implemented to minimise disruption to pupils' education.
- **Individual Pupil Absences:** In cases where a pupil is absent for a short-term period due to medical recovery, injury, or exceptional circumstances but is well enough to learn, remote education may be provided.
- **Pupils with Additional Needs:** For pupils with special educational needs or mental health challenges affecting attendance, remote learning may be considered as part of a planned reintegration back into school.

### **Our Remote Learning Approach**

We aim to provide high-quality, meaningful, and accessible remote education that enables pupils to stay on track with their learning and remain connected with their teachers and peers.

### **Learning Materials**

- Pupils will have access to structured learning through the school website and/or Microsoft Teams, which may include recorded and/or live lessons, tasks, and reading materials.
- High-quality external resources, such as Oak National Academy lessons, may be used to supplement learning.
- Printed resources will be made available where required to support those with limited access to technology.

### **Expected Engagement**

- Pupils are expected to engage with remote learning activities in line with their usual school timetable, as much as possible.
- Teachers will provide regular feedback and opportunities for interaction to support learning.
- Parents and carers are encouraged to facilitate a structured learning routine at home.

### **Support for Pupils and Families**

- We will work with families to address any barriers to accessing remote education, including providing school-owned devices, where available.
- Special consideration will be given to pupils with SEND to ensure they receive appropriate support tailored to their needs.
- Our safeguarding measures will remain in place, with regular well-being checks and guidance on safe online learning practices.

### **Attendance and Reintegration**

- Pupils receiving remote education will still be recorded as absent in the school register in line with attendance regulations.
- Remote education will be reviewed regularly and will not replace the importance of in-person attendance. A clear plan for reintegration will be established for each pupil to return to school as soon as possible.

### **Communication and Support**

- Parents and carers will be informed of any remote learning arrangements via our school website and/or direct communication channels.
- Families eligible for free school meals may receive appropriate support, such as meal parcels or vouchers, during any period of remote education, as determined by local or national government.
